Public Consultation Information

As per the TII Code of Practice for Greenways, the route corridor options being considered are being put on display for the second Public Consultation for this project. Figure 1 illustrates the route corridor options being considered. More detailed maps of these routes are also published online, as part of this public consultation, and are available on Clare County Council's website www.clarecoco.ie. These drawings will be on display, with this brochure and a comment form, at the following two locations from Friday 9th September to Friday 30th September 2022:

> Kilrush Public Library Sweeney Memorial Library, Kilkee

Information sessions will be held on Wednesday 14th September in Kilrush and Thursday 15th September in Kilkee at the above-mentioned locations, from 3:30pm to 8:30pm on each day with members of Clare County Council and the scheme consultants ROD in attendance. Private individual landowner consultations can be facilitated during the information sessions for potentially affected landowners.



Route Corridor Options

A number of potential end-to-end route corridor options were developed using a combination of the viable links that emerged from the initial route options assessment process, as described over. A map illustrating the potential route corridor options is included in Figure 1 overleaf. The end-to-end route corridor options from Kilkee to Kilrush have been broken down into 5 sub-sections to assist with the route selection process as follows:

- Sub-section A from Kilkee to Blackweir Bridge
- Sub-section B from Blackweir Bridge to Moyasta
- Sub-section C from Moyasta to Carnacalla South
- Sub-section D from Carnacalla South to Kilrush
 Marian
- Sub-section E from Kilrush Marina to Cappagh Pier In certain places within these sub-sections, only one viable option has emerged. In other places, there are a number of local corridor options remaining, including deviations from the original West Clare Railway route corridor. Where practicable, these corridors will make use of local roads, farm boundaries or field boundaries to minimise impacts on land-holdings. At this stage, all route corridor options are subject to ongoing ecological data collection

These route corridor options, referenced by sub-section, are shown on the map in different colours. The colour of each route corridor option has no significance, other than to differentiate it from other, alternative route corridor options.

Where these route corridor options exist within a given subsection, each option has been assigned an identifying label in the form of Option A-1, Option A-2 etc. as shown in Figure 1, to assist you in referencing a particular route corridor option in your submission.

Next Steps

Following this public consultation, the information and submissions received will be reviewed by Clare County Council together with the scheme consultants ROD. This information will assist in informing the selection of the Preferred Route Corridor as part of a qualitative appraisal of the route corridor options. The qualitative appraisal of the route corridor options shown on Figure 1 will be carried out in accordance with the TII Project Appraisal Guidelines as a Multi-Criteria Analysis [MCA] under the following set criteria:

- Environment
- Safety
- •AY Economy
- CK Accessibility & Social Inclusion
- Integration
- Physical Activity

A draft Options Selection Report will be prepared to assess each route corridor option through the MCA, which compares the relative advantages and disadvantages of options, while also highlighting areas that might warrant further thought and consideration. This process will result in the selection of the Preferred Route Corridor, which will be subject to a further public consultation at a later date.
