

Route Corridor Options

A map illustrating the potential route corridor options is included in Figure 2 overleaf. The end-to-end route corridor options from Ennis to Ennistymon have been broken into 7 sub-sections to assist the route corridor selection process as follows:

Sub-section A - Ennis Options

Sub-section B - Ennis to Ballygriffy South

Sub-section C - Ballygriffy South to Ballykinnacorra

Sub-section D - Corofin Area

Sub-section E - Ballykinnacorra to Craggaunboy

Sub-section F - Craggaunboy to Cullenagh

Sub-section G - Cullenagh to Ennistymon

Where practicable, these route corridor options will make use of public land, local roads, existing trails, farm boundaries or field boundaries to minimise impacts on land-holdings.

These route corridor options, referenced by sub-section, are shown on the map in different colours. The colour of each route corridor option has no significance, other than to • differentiate it from other route corridor options. Each option . has been assigned an identifying label in the form of Option; B-1, B-2, etc. to assist you in referencing a particular route corridor option in your submission. In some areas, there have as B-1(i), B-2(i) etc., illustrated with dashed outlines in Figure

connecting the greenway to the town centre are shown as linear route options rather than wide route corridor options at a later date.

to show it is generally intended to follow or connect existing transportation corridors in the urban area. Where route options are located along existing streets they will require urban realm works to improve active travel facilities. A more detailed view of the route options being considered in Ennis is shown in Figure 1.

Next Steps

Following this public consultation, the information and submissions received will be reviewed by Clare County Council together with the scheme consultants ROD. This information will assist in informing the selection of the Preferred Route Corridor as part of a qualitative appraisal of the route corridor options. The qualitative appraisal of the route corridor options shown in Figures 1 and 2 will be carried out in accordance with the TII Project Appraisal Guidelines as a Multi-Criteria Analysis under the following set criteria:

- Environment

- Accessibility & Social Inclusion
